"I, (state your name), do solemnly swear (or affirm) that I will faithfully discharge the duties of the office of member of the Board of Education of Community Unit School District number 15 of in accordance with the Constitution of the United States, the Constitution of the State of Illinois, and the laws of the State of Illinois, to the best of my ability

I further swear (or affirm) that:

I shall respect taxpayer interests by serving as a faithful protector of the School Districts assets;

I shall encourage and respect the free expression of opinion by my fellow Board members and others who seek a hearing before the Board, while respecting the privacy of students and employees;

I shall recognize that a Board member has no legal authority as an individual and that decisions can be made only by a majority vote at a public Board meeting;

I shall abide by majority decisions of the Board, while retaining the right to seek changes in such decisions through ethical and constructive channels;

As part of the Board of Education, I shall accept the responsibility for my role in the equitable and quality education of every student in the School District;

I shall foster with the Board extensive participation of the community, formulate goals, define outcomes, and set the course for Community Unit School District number 15;

I shall assist in establishing a structure and an environment designed to ensure all students have the opportunity to attain their maximum potential through a sound organizational framework;

I shall strive to ensure a continuous assessment of student achievement and all conditions affecting the education of our children, in compliance with State law;

I shall serve as education's key advocate on behalf of students and our community's schools to advance the vision for Community Unit School District number 15; and

I shall strive to work together with the District Superintendent to lead the School District toward fulfilling the vision the Board has created, fostering excellence for every student in the areas of academic skills, knowledge, citizenship, and personal development.

#### Seating of Board Members

Note: If only one member is nominated, the Secretary Pro tem is instructed by the President Pro tem to record a unanimous vote for that member and that member is thereby declared elected. If two or more members are nominated, the Secretary Pro tem is instructed to call the roll, whereupon the members may vote for any nominated member. After a member is declared elected President, the President Pro tem relinquishes the chair to the elected President. Note, the election must be done by voice vote. Written votes are not permissible.

Vice President

BOE Member #1 - Matt Seman: "I move to nominate Charlie Waugh to serve as Board Vice President."

BOE Member #2 - Tom Ray: "Second."

Note: If only one member is nominated, the Secretary Pro tem is instructed by the President Pro tem to record a unanimous vote for that member and that member is thereby declared elected. If two or more members are nominated, the Secretary Pro tem is instructed to call the roll, whereupon the members may vote for any nominated member. The President then declares the candidate receiving the most votes to be the duly elected Vice President of the Board. Secretary

BOE Member #2 - Kurt Ratliff: "Second."

If two or more members are nominated, the Secretary Pro tem is instructed to call the roll, whereupon the members may vote for any nominated member. The President then declares the candidate receiving the most votes to be the duly elected Secretary of the Board.
