A. Superintendent's Report

1. Financial Update

Mr. Root presented a 2005-2015 cash flow analysis and reiterated where we are at the end of November with a balance in all funds of \$6,050,604 and a balance in the Operating Funds of \$4,482,406. By comparison, at the end of November 2014, our balance in all funds was \$6,946,577 and in the Operating Funds was \$5,219,457.

Mr. Root informed the Board the State is behind in payments totaling around \$350,000. They are also late on delayed and prorated payments. He noted this is reflected in the operating fund balances. We have also paid back the \$250,000 to the Village of Sherman, and that is reflected as well. Mr. Root said we will keep moving forward for our students, but the bleed continues. He noted we are purchasing math text books and Chromebooks for use in the classroom.

3. III Conference Information Sharing

Mr. Root stated he enjoyed the conference and that finance was again a big topic discussed. He then opened the discussion for the Board to share their insights from the conference.

Members attended sessions on finance, the handling of a referendum by another district, the separation of religion and public schools and superintendent contracts. Many members noted the conference highlighted how well our Administration and Board work together and how it was nice to be able to get to know other members on a personal level.

A question was raised to see if we are participating with crime stoppers tip lines in schools. This allows students to call in anonymously and report illegal behaviors. It was stated that we currently do not participate in this particular program, but that we have something in place in each building for similar reporting.



4. Chromebook Labs - PTO \$30,000 donation

Mr. Root thanked the PTO for their \$30,000 donation for Chromebooks for the elementary school. This donation, along with \$20,000 from the school district will provide for 6 Chromebook carts, each containing 23 Chromebooks. Mr. Root also thanked Technology Director, Chris Wherley, for finding the Chromebooks for a great price of about \$150 per Chromebook.
