**COVID-19 Sports and Open Gym Participation Consent Form: Stage 4**

**Purpose:** The purpose of this form is to obtain consent for your student to participate in sports taking place at Williamsville School District facilities during the COVID-19 pandemic within Phase 4 of the IESA and IHSA Return to Play Plan. By signing below, you give consent for your student to participate at workouts, practices, and games being held at Williamsville School District facilities. This form must be returned at the first practice or workout. Students that do not have a consent form signed will not be allowed to participate.

**2020-2021 Sports and Open Gym Participation – Williamsville CUSD #15 Activities**

Williamsville CUSD #15, in accordance with both IESA and IHSA Phase 4 of Return to Play guidelines, has established the following requirements for its coaches and athletes:

1. The same check-in procedures that were utilized during phase three will be continued.
2. Coaches will maintain a daily record of what athletes are participating. Coaches will also monitor students for any symptoms that they may present.
3. Students will follow the procedures that have been setup in regard to entering and exiting district facilities in order to avoid intermingling during departure and arrival.
4. Groups of fifty individuals, indoors or outdoors are allowed. At least thirty feet of space will be maintained between groups.
5. The level of play is dictated by public health conditions when the sport or activity is played. The four-level chart of play and sport risk level chart developed by the State of Illinois will be followed when planning workouts, practices, and games.
6. Athletes and coaches will be required to wear masks at all times when they are inside. Athletes and coaches will be required to wear a mask outside when they cannot maintain proper social distancing per CDC and IDPH guidelines.
7. Students are allowed to participate in multiple sports during contact days and open gyms, but participation is limited to five hours a day.
8. Spotters for weightlifting are allowed but will stand at each end of the bar. Spotters will be required to wear a mask.
9. Teams in medium risk sports may have intra-squad scrimmages with their own players.
10. All frequently touched surfaces, objects, and equipment will be cleaned and disinfected regularly.
11. Players must bring their own water bottle, shoes, towels, and other personal equipment. The use of locker rooms, shared water coolers with cups, and water fountains will be prohibited.
12. Individuals must not participate if they do not feel well or have been in close contact with someone who has been diagnosed with COVID-19.
